CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of BEAR CREEK, a tributary of CROOKED RIVER, for IRRIGATION of 111.00 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County recorded in the Order Record of the Water Resources Department in Volume 1, at Page 449. The date of priority is 1902. This right is limited to 1.39 CUBIC FEET PER SECOND or the equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:



This certificate supersedes Certificate 554.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights.
