## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOST AND BOULDER DITCH CO. P.O. BOX 12 WAMIC, OR 97063

confirms the right to use the waters of LOST AND BOULDER CREEKS, tributaries of the WHITE RIVER for IRRIGATION OF 540.35 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7 and 11, at Pages 196 and 416, respectively. The date of priority is 1911.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 13.11 CFS UP TO JULY 1 AND THEREAFTER 6.35 CFS, which shall be further limited to a maximum diversion of 1451.0 ACRE FEET, and not to exceed 1.0 ACRE-FOOT PER ACRE during any 30 day period up to July 1 of each year and not to exceed 3.0 ACRE-FEET PER ACRE during any irrigation season, provided that the rate of flow shall not exceed ONE-FORTIETH OF A SECOND FOOT PER ACRE up to July 1 of each year and thereafter not to exceed ONE-EIGHTIETH OF A SECOND FOOT PER ACRE, except in the case of rotation.
