confirms the right to use the waters of a WELL in the SQUAW CREEK BASIN for SUPPLEMENTAL IRRIGATION of 76.7 acres.

This right was perfected under Permit G-7092. The date of priority is DECEMBER 26, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.96 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right is limited to any deficiency in the available supply of any prior right existing for the same land. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. A description of the place of use to which this right is appurtenant is as follows:
