## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN DAY P.O. BOX 488 MEDFORD, OREGON 97501

confirms the right to use the waters of the ROGUE RIVER, TRIBUTARY OF PACIFIC OCEAN, for IRRIGATION of 204.58 ACRES.

This right was perfected under Permit 23796. The date of priority is July 28, 1955. The right is limited to not more than 2.55 cubic feet per second (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
