CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Eric and Sue Borst 7625 Buena Vista Road Independence, OR 97351

confirms the right to use the waters of Willamette River, a tributary of Columbia River, for SUPPLEMENTAL IRRIGATION of 22.8 acres.

This right was perfected under Permit 32448. The date of priority is March 20, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.25 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

POD 1: Lot 5, NW ¼ SW ¼, Section 34; 1,370 feet North and 720 feet East, from the SW corner of Sec. 34, T. 8 S., R. 4 W., W.M. and POD 2: Lot 6, SE ¼ SW ¼, Section 34; 890 feet North and 2,275 feet East, from the SW corner of Sec. 34, T. 8 S., R. 4 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that although declared therein to be for supplemental irrigation the right allowed may, in the interest of conserving the ground water supplies, be exercised at times then water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed therein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
