CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Norvil Greener, C.L. Thomas,
and Lovell Gover
Halfway, OR 97834

confirms the right to use the waters of CLEAR CREEK, a tributary of PINE CREEK, for IRRIGATION of 40.0 acres and SUPPLEMENTAL IRRIGATION of 272.0 acres.

This right was perfected under Permit 6844. The date of priority is May 25, 1925. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 3.90 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 9, Township 8 South, Range 46 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
