CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILSON DITCH COMPANY  
501 FULLERTON ROAD  
ECHO, OREGON 97826

confirms the right to use the waters of UMATILLA RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 26.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Page 457. The date of priority is DECEMBER 15, 1904.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.33 CUBIC FOOT PER SECOND, (IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION DESCRIBED AS THE WILSON DITCH), or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WILSON DITCH - SE 1/4 SW 1/4, SECTION 22, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.; 400 FEET NORTH AND 330 FEET WEST FROM THE SOUTH 1/4 CORNER, SECTION 22;

WILSON DITCH - NW 1/4 NE 1/4, SECTION 27, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.; 200 FEET SOUTH AND 1120 FEET EAST FROM THE SOUTH 1/4 CORNER, SECTION 22; AND

FURNISH CANAL - SW 1/4 SW 1/4, SECTION 31, TOWNSHIP 3 NORTH, RANGE 30 EAST, W.M.; 380 FEET NORTH AND 650 FEET EAST FROM THE SW CORNER, SECTION 31.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NE 1/4 1.0 ACRE  
SECTION 21

NW 1/4 NW 1/4 1.6 ACRES  
BEING WITHIN THAT PORTION LYING SW OF THE RR RIGHT-OF-WAY

NE 1/4 SW 1/4 10.5 ACRES  
NW 1/4 SW 1/4 12.7 ACRES  
SE 1/4 SW 1/4 0.8 ACRE  
LYING NE OF THE RAILROAD RIGHT-OF-WAY  
SECTION 22

TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.

The water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgates and measuring devices must be approved by the Department.

The water user shall report total flow figures when requested by the Department. The Watermaster may operate the headgates and monitor accuracy of the measuring devices, as needed.


This certificate describes that portion of the water right confirmed by Certificate 80980, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered August 30, 2005, approving Transfer Application 7919.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
