## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the LITTLE APPLEGATE RIVER, a tributary of the APPLEGATE RIVER for IRRIGATION of 161.64 ACRES and LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 2, at Page 339. The date of priority is SEPTEMBER 1, 1857. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.22 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
