confirms the right to use the waters of SEVEN (7) WELLS in the UMATILLA RIVER BASIN for PRIMARY IRRIGATION OF 59.4 ACRES AND SUPPLEMENTAL IRRIGATION of 2.6 acres.

This right was perfected under Permit G-10505. The date of priority is JANUARY 9, 1970. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.78 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.
