confirms the right to use the waters of SOUTH FORK WALLA WALLA RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 2.5 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is recorded in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1891.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW¼ NW¼ 2.5 ACRES
SECTION 10
TOWNSHIP 4 NORTH, RANGE 37 EAST, W.M.

The right to the use of the water for the above purposes is restricted to the lands or place of use described and is subject to all other conditions and limitations contained in said decree.



This certificate describes the water right confirmed by the Stipulation and Order signed on December 21, 2005, by Judge Garry L. Reynolds of the Circuit Court of the State of Oregon for Umatilla County. The Stipulation and Order is recorded in the Order Record of the Water Resources Director in Volume 19, at Page 129, and corrects the Decree to clarify the location of the place of use of a water right in the name of W. G. Coleman. This certificate supersedes and replaces Certificate 12602, issued by the Oregon State Engineer pursuant to ORS 539.140.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
