CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROATS WATER SYSTEM, INC.
61147 HAMILTON LANE
BEND, OREGON 97702

confirms the right to use the waters of WELL NO. 2 in the DESCHUTES BASIN for GROUP DOMESTIC USE AND IRRIGATION OF 6.0 ACRES

This right was perfected under Permit G-3128. The date of priority is DECEMBER 22, 1965. This right is limited to 0.56 CUBIC FOOT PER SECOND; BEING 0.50 CFS FOR GROUP DOMESTIC AND 0.06 CFS FOR IRRIGATION cubic foot per second or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NW 1/4, SECTION 17, TOWNSHIP 18 SOUTH, RANGE 12 EAST, W.M.; 300 FEET SOUTH AND 320 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 17.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.


