CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the LUCKIAMUTE RIVER, WILLAMETTE RIVER AND SLOUGH THEREOF, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 71.4 ACRES.

This right was perfected under Permit 25777. The date of priority is AUGUST 4, 1958 FOR 0.44 CUBIC FOOT PER SECOND AND OCTOBER 24, 1958 FOR 0.45 CUBIC FOOT PER SECOND. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.89 CUBIC FOOT PER SECOND; BEING 0.21 CFS FROM THE LUCKIAMUTE RIVER, AND 0.68 CFS FROM THE WILLAMETTE RIVER AND SLOUGH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SLOUGH - NW 1/4 NE 1/4, AS PROJECTED WITHIN MILLER DLC 52, SECTION 2, T 10 S, R 4 W, W.M.;

WILLAMETTE RIVER - SE 1/4 NW 1/4, AS PROJECTED WITHIN MILLER DLC 52, SECTION 2, T 10 S, R 4 W, W.M.; AND

LUCKIAMUTE RIVER - LOT 10 (NW 1/4 NW 1/4), SECTION 2, T 10 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
