CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LAKE CREEK, a tributary of the METOLIUS RIVER for IRRIGATION, LIVESTOCK AND DOMESTIC USE on 54.61 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Deschutes County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 9, at Page 362. The date of priority is 1888.

The use is limited to 3 acre-feet per acre, measured at the point of diversion from the stream, which may be diverted at a rate of not to exceed $1/60^{\text{th}}$ cubic foot per second per acre during the irrigation season from May 1 to September 15, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by Certificate 68373, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered August 19, 2005, Special Order Volume 66, page 146, approving Transfer Application 9807, and an order entered September 16, 2005, Special Order Volume 67, page 143, correcting the total acreage under the right, canceling a portion of the right, and clarifying the point of diversion for lands in the NW¼ NW¼ of Section 15, tax lots 300, 302 and 304.

This certificate supersedes Certificate 81535 and corrects a scrivener's error in the number of acres in the place of use listing in Certificate 81535.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
