CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Shotgun Ranch LLC 2730 Nightfall Bend, OR 97701

confirms the right to use the waters of Shotgun Creek and Drake Creek, tributaries of Crooked River, for irrigation of 32.0 acres, stock and domestic use.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at page 449. The priority of the right dates from the year 1889 for the waters of Shotgun Creek, and from the year 1903 for the waters of Drake Creek.

The amount of water to which this right is entitled is limited to an amount actually beneficially used from February 1st to December 1st of each year, and shall not exceed 0.25 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion on Shotgun Creek, and shall not exceed 0.15 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion on Drake Creek.

The points of diversion are located as follows:

Shotgun Creek: SE% NW%, Section 9, T17S, R20E, W.M.; 1,940 feet South and 100 feet West from the N % corner, Section 9.

Drake Creek: NW% SW%, Section 10, T17S, R20E, W.M.; Ream Ditch.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
