CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DOUBLE M RANCH, INC. P.O. BOX 38 ADAMS, OREGON 97810

confirms the right to use the waters of WELL #1 and WELL #2, within the UMATILLA RIVER BASIN, for IRRIGATION of 17.10 ACRES and SUPPLEMENTAL IRRIGATION of 10.20 ACRES.

This right was perfected under Permit G-3971. The date of priority is FEBRUARY 1, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.34 CUBIC FOOT PER SECOND, or the equivalent in case of rotation, measured at the WELLS.

The points of appropriation are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or the equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet for each acre irrigated during the irrigation season of each year, provided further that the right for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under this right, and to which such right is appurtenant, is as follows:

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
