CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL, a tributary of the POWDER RIVER BASIN, for SUPPLEMENTAL IRRIGATION of 100.85 ACRES.

This right was perfected under Permit G-7630. The date of priority is JUNE 9, 1977. This right is limited to 1.26 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall further be limited to a diversion not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 72620, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered February 22, 2006, and recorded in Special Order Volume 68, Page 71, canceling a portion of the water right. This certificate supersedes Certificate 72620.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
