CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CHAPMAN WELL 1 AND 2 in the COLUMBIA RIVER BASIN for IRRIGATION OF 138.48 ACRES.

This right was perfected under Permit U-725. The date of priority is MAY 2, 1955. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.728 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1: SE $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 28, TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.; 56 CHAINS NORTH AND 21.5 CHAINS EAST FROM THE SW CORNER, SECTION 28.

WELL 2: NW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 28, TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.; 24.5 CHAINS NORTH AND 19.5 CHAINS EAST FROM THE SW CORNER, SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


