

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

confirms the right to use the waters of TWO PIT WELLS in the UMATILLA BASIN for IRRIGATION OF 3.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 147.0 ACRES FROM PIT WELL # 1; AND IRRIGATION OF 2.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 262.5 ACRES FROM PIT WELL # 2.

This right was perfected under Permit G-10709. The date of priority is DECEMBER 2, 1985. This right is limited to 4.93 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

PIT WELL # 1: NE 1/4 NE 1/4, SECTION 35, T 4 N, R 28 E, W.M.; 700 FEET SOUTH AND 825 FEET WEST FROM THE NE CORNER, SECTION 35;

PIT WELL # 2: SE 1/4 SE 1/4, SECTION 35, T 4 N, R 28 E, W.M.; 85 FEET NORTH AND 275 FEET WEST FROM THE SE CORNER, SECTION 35.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that use of water under this permit shall be limited to the appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of Umatilla River or any tributary thereof; any depletion will require the wells to be shut down unless the Order of Withdrawal of the Umatilla River and its tributaries by the Water Resources Commission dated December 2, 1985, is not extended or amended, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
