CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLYDE HOLLIDAY FAMILY RANCHERS, INC. HCR 77 Box 90 John Day, Oregon 97845

confirms the right to use the waters of the PINE CREEK, a tributary of the JOHN DAY RIVER, for IRRIGATION of 223.3 ACRES.

This right was perfected under Permit 49885. The date of priority is NOVEMBER 7, 1986. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 5.58 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use stated herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
