

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

confirms the right to use the waters of NEHALEM RIVER, a tributary of NEHALEM BAY, for IRRIGATION OF 0.1 ACRE AND STOCK WATER.

This right was perfected under Permit 48242. The date of priority is OCTOBER 7, 1983. This right is limited to 0.006 CUBIC FOOT PER SECOND (CFS), BEING 0.001 CFS FOR IRRIGATION AND 0.005 CFS FOR STOCK WATER or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 6 (NE 1/4 SW 1/4), SECTION 14, T 6 N, R 5 W, W.M.; 2150 FEET NORTH AND 280 FEET WEST FROM THE S 1/4 CORNER OF SECTION 14.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.


A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
