CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICK, CANTRELL  
RT 1 BOX 115  
DUFUR OR 97021

confirms the right to use the waters of A WELL, tributary to RAMSEY CREEK, for SUPPLEMENTAL IRRIGATION of 0.9 ACRE.

This right was perfected under Permit G-6778. The date of priority is APRIL 27, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.005 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

1 S	13 E	WM	31	SW SE	430 FEET NORTH & 3460 FEET EAST FROM SW CORNER, SECTION 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.


A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued in accordance with OAR 690-OAR 690-380-6010 to describe the portion of the water right confirmed by Certificate 50552 for a non-completed change in point of diversion approved by of an order of the Water Resources Director entered December 22, 2003, at Special Order Volume 58, Page 388, approving transfer T-9016, and NOT modified by provisions of an order approving transfer T-6825, entered June 26, 2006 at Special Order Volume 68, Page 791, and supersedes Certificate 50552, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
