CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICK CANTRELL ROUTE 1, BOX 115 DUFUR, OREGON 97021

confirms the right to use the waters of the WELL #2, within the FIFTEENMILE CREEK BASIN, for SUPPLEMENTAL IRRIGATION OF 183.3 ACRES.

This right was perfected under Permit G-7444. The date of priority is APRIL 11, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.764 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW¼ NE¼, SECTION 6, T 2 S, R 13 E, W.M.; 330 FEET SOUTH AND 3530 FEET EAST FROM THE NW CORNER, SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
