CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

Grande Ronde Valley Irrigation Company
205 Main Street
La Grande, OR 97850

confirms the right to use the waters of Grande Ronde River, a tributary of Snake River, for IRRIGATION of 605.3 acres.

This right was perfected under Permit 902. The date of priority is July 25, 1911. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 7.57 CUBIC FEET PER SECOND if available at the original point of diversion described as being within the SW1/4 SW1/4, Section 32, T 2 S, R 38 E, W.M., or its equivalent in case of rotation measured at the point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
