

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

confirms the right to use the waters of TWO SPRINGS, AN UNNAMED STREAM, AND A RESERVOIR, tributaries of NORTH YAMHILL RIVER for STOCK USE AND FISH CULTURE.

This right was perfected under Permit 36848. The date of priority is JULY 11, 1972. This right is limited to 0.035 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FOR FISH CULTURE; 0.02 CFS FROM EAST SPRING FOR STOCK USE; AND 0.005 CFS FROM WEST SPRING FOR STOCK USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WEST SPRING: SW 1/4 NE 1/4, SECTION 35, T 2 S, R 5 W, W.M.; 740 FEET NORTH AND 1030 FEET EAST FROM THE CENTER OF SECTION 35.

EAST SPRING: SE 1/4 NE 1/4, SECTION 35, T 2 S, R 5 W, W.M.; 980 FEET NORTH AND 220 FEET WEST FROM EAST QUARTER CORNER SECTION 35.

UNNAMED STREAM/RESERVOIR: NE 1/4 NE 1/4, T 2 S, R 5 W, W.M.; 1390 FEET NORTH AND 680 FEET WEST FROM EAST QUARTER CORNER OF SECTION 35


