CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT MACE

Central Point, Oregon 97502

confirms the right to use the waters of ROGUE RIVER, A TRIBUTARY OF THE PACIFIC OCEAN, for IRRIGATION OF 26.3 ACRES.

This right was perfected under Permit 25859. The date of priority is NOVEMBER 18, 1958. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.33 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion at the source.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The point of diversion is located as follows:

LOT 2 (NW ¼ SE ¼), SECTION 15, T 36 S, R 2 W, W.M.; LOCATED 2438 FEET NORTH AND 1450 FEET WEST OF THE SE CORNER OF SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or it's equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4¼ acre-feet for each acre irrigated during the irrigation season of each year.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans for the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the supervision of the Department.

The water user shall maintain and operate fish screening and by-pass devices that have been approved by the Oregon Department of Fish and Wildlife.

This certificate is issued to confirm a change in CHANGE IN PLACE OF USE AND USE approved by an order of the Water Resources Director entered October 8, 2001, and together with certificate 77051 supersedes Certificate 34239, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
