**CERTIFICATE OF WATER RIGHT**

THIS CERTIFICATE ISSUED TO

OCHOCO IRRIGATION DISTRICT  
 1001 NW DEER STREET  
 PRINEVILLE, OREGON 97754

This certificate confirms the right to use the waters of the OCHOCO, MCKAY, DRY, LYTLE AND JOHNSON CREEKS and ALL WASTE AND RETURN WATER FLOWING IN ALL UNNAMED WATERWAYS and OCHOCO RESERVOIR CONSTRUCTED UNDER PERMIT R-528, a tributary of the CROOKED RIVER for IRRIGATION of 16614.3 ACRES and INDUSTRIAL USE of 160.2 ACRES/EQUIVALENT.

The right was perfected under Permit 5426. The date of priority is MARCH 13, 1916, from MCKAY CREEK and AUGUST 10, 1917, from ALL OTHER SOURCES NAMED HEREIN. The right is limited to an amount actually beneficially used and shall not exceed 209.7 CUBIC FEET PER SECOND (cfs), or the equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or the equivalent) for each acre irrigated and shall be further limited to 4.0 acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**NOTE:** Tax lot numbers preceded by an asterisk (\*) in the supplemental information column of the following place of use listing denotes that the tax lot extends over more than one quarter-quarter section of land.

**INDUSTRIAL:** The irrigation equivalent acres for the industrial water rights are listed and located by quarter-quarter sections of land within which the tax lot listed in the supplemental information column is located. The place of use for the irrigation equivalent acres of industrial water right is authorized for use anywhere within the tax lot and is not apportioned between the quarter-quarter sections of land. Where "w/in service area" appears in the tax lot column, the legal description identifies the quarter-quarter section of land adjacent to the Ochocho Feed Canal where water is diverted from the source, and the place of use for the irrigation equivalent acres industrial water right is authorized for use anywhere within the service area of the district.

**IRRIGATION:** Because irrigation water rights on tracts of land less than 5.0 acres in size need not be mapped under ORS 541.329(2)(d) and need only be identified by tax lot number, the irrigation water right by acres is listed and located according to the quarter-quarter in which the largest portion of the tax lot is located.
