confirms the right to use the waters of OCHOCO CREEK, a tributary of the CROOKED RIVER, for IRRIGATION OF 199.3 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record in Salem, in the Order Record of the Water Resources Department, in Volume 1, at page 449. The date of priority is 1884 for 79.7 ACRES and 1903 for 119.6 ACRES.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.42 CUBIC FEET PER SECOND and a reasonable amount for stock and domestic use. The right is further limited to a total quantity not to exceed 4.0 acre feet per acre during each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
