CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

AZUR TILE, INC. 4550 NE JOHNSON CREEK ROAD PRINEVILLE OR 97754

confirms the right to use the waters of JOHNSON CREEK AND JOHNSON CREEK RESERVOIR constructed under Application R-25574, Permit R-1303, a tributary of OCHOCO CREEK, for SUPPLEMENTAL IRRIGATION OF 43.2 ACRES.

This right was perfected under Permit 21003. The date of priority is SEPTEMBER 17, 1951. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.03 CUBIC FOOT PER SECOND from Johnson Creek and 369.0 acre feet stored water, or the equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other water right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated from direct flow and shall further be limited to a diversion not to exceed 4.0 ACRE FEET per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from the reservoir constructed under Permit R-1303 and shall be still further limited to the use of stored water on those lands described.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
