## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RAYMOND AND SANDRA SHANAFELT 8790 NW CAMPBELL RANCH RD PRINEVILLE OR 97754

confirms the right to use the waters of CROOKED RIVER, a tributary of the DESCHUTES RIVER, for SUPPLEMENTAL IRRIGATION OF 75.0 ACRES.

This right was perfected under Permit 2309. The date of priority is DECEMBER 21, 1914. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.94 CUBIC FOOT PER SECOND if available at Diversion #1, or the equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other water right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
