CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PILOT BUTTE HEREFORD RANCH, INC. BOX 525 PRINEVILLE OR 97754

confirms the right to use the waters of BREEZE WELL #1, a tributary of OCHOCO CREEK, for SUPPLEMENTAL IRRIGATION OF 20.0 ACRES.

This right was perfected under Permit G-1465. The date of priority is OCTOBER 9, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.25 CUBIC FOOT PER SECOND, or the equivalent in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other water right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 ACRE FEET per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate supersedes water right certificate 30932 in the name of Pilot Butte Hereford Ranch, Inc.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
