CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO  
CHRIS RALPH  
950 KUBLI RD  
GRANTS PASS OR 97526

confirms the right to use the waters of THREE WELLS within the CARIS CREEK BASIN (APPLEGATE RIVER) for IRRIGATION AND SUPPLEMENTAL IRRIGATION of 4.0 ACRES.

This right was perfected under Permit G-2067. The date of priority is MARCH 1, 1962. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued to correct scrivener's errors in the place of use contained in the certificate recorded at page 81892, State Record of Water Right Certificates. This certificate supersedes Certificate 81892 and describes the portion of the water right NOT modified by the provisions of orders of the Water Resources Director approving and correcting Transfer Application T-9253, entered May 31, 2006 and recorded in Special Order Volume 68, Page 555 and Special Order Volume 69, Page 658 entered August 17, 2006.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
