CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of MILL CREEK, a tributary of the CATHERINE CREEK AND THE GRANDE RONDE RIVER, for IRRIGATION OF 15.0 ACRES FROM MAY 1 TO OCTOBER 1 OF EACH YEAR.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION County. The decree is of record at Salem, in the Order of Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 207. The date of priority is 1868.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 CUBIC FOOT PER SECOND (CFS), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

(SELDER-WRIGHT DITCH) SW 1/4 SW 1/4, SECTION 24, T 3 S, R 40 E, W.M.; 180 FEET NORTH AND 560 FEET EAST FROM THE SW CORNER, SECTION 24.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4      3.5 ACRES  
NW 1/4 SW 1/4      11.5 ACRES  
SECTION 24

TOWNSHIP 3 SOUTH, RANGE 40 EAST, W.M.


