CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN M. MILLER  
70057 HIDDEN VALLEY LANE  
COVE, OREGON 97824

confirms the right to use the waters of MILL CREEK, a tributary of GRANDE RONDE RIVER, for SUPPLEMENTAL IRRIGATION for 15.0 ACRES.

This right was perfected under Permit 31925. The date of priority is AUGUST 31, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year; provided further that the right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be limited to the period between September 1 and April 30 of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 24, T 3 S, R 40 E, W.M.; 180 FEET NORTH  
AND 560 FEET EAST FROM THE SW CORNER, SECTION 24.

A description of the place of use to which this right is appurtenant is as follows:


SW 1/4 NW 1/4        3.5 ACRES  
NW 1/4 SW 1/4       11.5 ACRES  
SECTION 24  
TOWNSHIP 3 SOUTH, RANGE 40 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered on April 13, 1998, approving Transfer Application T-7938, and together with Certificate 75574 supersedes Certificate 42768, State Record of Water Right Certificates.
