CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MALCOLM SKINNER

confirms the right to use the waters of A WELL in the UMATILLA RIVER BASIN for IRRIGATING 24.0 ACRES.

This right was perfected under Permit G-3966. The date of priority is JANUARY 23, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.30 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL WELL: NE 1/4 SW 1/4, SECTION 18, T 4 N, R 28 E, W.M.; 10 FEET SOUTH AND 1110 FEET EAST FROM THE W 1/4 CORNER, SECTION 18), or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SE 1/4, SECTION 13, T 4 N, R 27 E, W.M.; 1820 FEET NORTH AND 1230 FEET EAST FROM THE S 1/4 CORNER, SECTION 13.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water available from the original point of appropriation.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4 24.0 ACRES
SECTION 13
TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The well at the new point of appropriation shall be constructed to the well construction standards in effect as of the date of the approval date of the transfer order and must include an access port.

Water shall be acquired from the same aquifer as the original point of appropriation.


The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered FEBRUARY 5, 1991, approving Transfer Application T-6415, and supersedes Certificate 51166, State Record of Water Right Certificates.
