

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for INDUSTRIAL USE TO INCLUDE LOG DECK SPRINKLING AND OPERATION OF CO-GENERATION POWER PLANT (WATER TREATMENT, GLAND WATER, RECHARGE WATER AND RECHARGE WATER FOR BOILER AND COOLING TOWER).

This right was perfected under Permit 49760. The date of priority is JULY 14, 1986. This right is limited to 1.5 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 10, T 13 S, R 33 E, W.M.; 290 FEET NORTH AND 520 FEET WEST FROM EAST 1/4 CORNER, SECTION 10.
