A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LARSEN CREEK, a tributary of BEAR CREEK, for DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1903.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

ANDERSON DITCH: NW 1/4 SW 1/4, SECTION 35, T 37 S, R 1 W, W.M.; 60 FEET SOUTH AND 1100 FEET EAST FROM THE W 1/4 CORNER, SECTION 35

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4
ALL AS PROJECTED WITHIN SUTHERLAND DLC 56
SECTION 35
TOWNSHIP 37 SOUTH, RANGE 1 WEST, W.M.


This certificate describes that portion of the water right confirmed by Certificate 15918, Volume 13, State Record of Water Right certificates, NOT modified by the provisions of an order of the Water Resources Director entered APRIL 30, 1979, approving Transfer Application 4198.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
