This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DEAN AND SUZIE MALDONADO 201 NE PARK PLAZA DR, #200 VANCOUVER, WA 98684

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 4.1 ACRES.

This right was perfected under Permit 24073. The date of priority is JANUARY 12, 1956. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.10 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion (POD) are located as follows:

POD # 1: NW 1/4 SW 1/4, SECTION 31, T 10 S, R 26 E, W.M.; 1750 FEET NORTH AND 1150 FEET EAST FROM THE SW CORNER, SECTION 31.

POD # 2: SW 1/4 SW 1/4, SECTION 31, T 10 S, R 26 E, W.M.; 300 FEET NORTH AND 750 FEET EAST FROM THE SW CORNER, SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 7, 1983, approving Transfer Application 5172, and together with Certificate 75794, supersedes Certificate 22724, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
