CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM POLIMAN  
BAKER OR 97814

confirms the right to use the waters of the POWDER RIVER, a tributary of the SNAKE RIVER for IRRIGATION of 129.33 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is 1879 for 40.0 acres, 1885 for 40.0 acres, and 1901 for 49.33 acres.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.235 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:
