This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATION OF 9.0 ACRES.

The right has been perfected under Permit 24189. The date of priority is APRIL 30, 1956. The right is limited to not more than 0.22 CUBIC FOOT PER SECOND (if available at the original point of diversion, LAYCOCK-LONG DITCH: SW¼ NW¼, SECTION 21, T 13 S, R 31 E, W.M.; 100 FEET NORTH AND 690 FEET EAST FROM THE W¼ CORNER, SECTION 21), or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LAYCOCK-LONG DITCH: SW% NW%, SECTION 21, T 13 S, R 31 E, W.M.; 100 FEET NORTH AND 690 FEET EAST FROM THE W% CORNER, SECTION 21.

PUMP: SW% SE%, SECTION 19, T 13 S, R 31 E, W.M.; 1100 FEET NORTH AND 880 FEET EAST FROM THE S% CORNER, SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.
