

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GOLDEN RULE FARMS, INC.
PO BOX 255
CHRISTMAS VALLEY, OREGON 97641

confirms the right to use the waters of WELL 1 ON UNIT 1 for IRRIGATION OF 58.8 ACRES.

This right was perfected under Permit U-487. The date of priority is MARCH 4, 1952. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.73 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located as follows:

NE 1/4 SW 1/4, SECTION 27, T 27 S, R 17 E, W.M.; 2740 FEET SOUTH AND 2700 FEET WEST FROM NE CORNER, SECTION 27

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 36.8 ACRES
NW 1/4 SW 1/4 21.3 ACRES
NW 1/4 SE 1/4 0.7 ACRE

SECTION 27
TOWNSHIP 27 SOUTH, RANGE 17 EAST, W.M.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the pump system shall include an in-line flow meter, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that measuring device be installed under the general supervision of said Watermaster.


This certificate is issued to confirm a change in the PLACE OF USE approved by an order of the Water Resources Director entered NOVEMBER 3, 1983, approving Transfer 5239, and together with Certificate 51862, supersedes Certificate 31120, State Record of Water Right Certificates.

The right to use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
