

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRANK SPRIET
RT 1, BOX 75
BAKER CITY OR 97814

confirms the right to use the waters of MILL CREEK, AN UNNAMED STREAM, AND AN UNNAMED SPRING, tributaries of SALMON CREEK, for IRRIGATION OF 3.0 ACRES.

This right was perfected under Permit 50005. The date of priority is SEPTEMBER 2, 1986. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 33.6 GALLONS PER MINUTE (GPM), BEING 24.7 GPM FROM MILL CREEK, 5.2 GPM FROM THE UNNAMED STREAM AND 3.7 GPM FROM THE UNNAMED SPRING; or the equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

MILL CREEK: SW 1/4 NE 1/4, SECTION 1, T 9 S, R 38 E, W.M.; 1250 FEET SOUTH AND 1290 FEET WEST FROM N 1/16 CORNER, SE 1/4 NE 1/4, SECTION 1.

UNNAMED STREAM: SW 1/4 NE 1/4, SECTION 1, T 9 S, R 38 E, W.M.; 1090 FEET SOUTH AND 1410 FEET WEST FROM N 1/16 CORNER, SE 1/4 NE 1/4, SECTION 1.

UNNAMED SPRING: SE 1/4 NE 1/4, SECTION 1, T 9 S, R 38 E, W.M.; 1190 FEET SOUTH AND 1000 FEET WEST FROM N 1/16 CORNER, SE 1/4 NE 1/4, SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.


A description of the place of use to which this right is appurtenant is as follows:

TAX LOT 600 SE 1/4 NE 1/4 2.7 ACRES
SE 1/4 NE 1/4 0.3 ACRE
SECTION 1
TOWNSHIP 9 SOUTH, RANGE 38 EAST, W. M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
