This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

confirms the right to use the waters of ELK RIVER, a tributary of the PACIFIC OCEAN, for the purpose of DOMESTIC USE FOR THREE FAMILIES AND FISH HATCHERY.

The right has been perfected under Permit 33339. The date of priority is JANUARY 16, 1968. The right is limited to not more than 20.015 CUBIC FEET PER SECOND (CFS), BEING 0.015 CFS FOR DOMESTIC USE AND 20.000 CFS FOR FISH HATCHERY USE, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, or its equivalent in case of rotation, measured at the point of diversion from the source.
