 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

FRANK AND MANUEL SILVA AND WESTERN RIDGE LAND COMPANY

confirms the right to use the waters of the NORTH FORK JOHN DAY RIVER, a tributary of the JOHN DAY RIVER, for the purpose of IRRIGATING 22.7 ACRES.

This right has been perfected under Permit 46922. The date of priority is JUNE 28, 1982 for 0.49 cubic foot per second (cfs) and AUGUST 4, 1982 for 0.08 cfs. The right is limited to not more than 0.57 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under this right, and to which such right is appurtenant, is as follows:



The right to the use of the water for any purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate describes that portion of the water right confirmed by Certificate 60660, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered November 8, 2006, approving Transfer Application 9631.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
