CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GARNET PANKEY
30756 PEACH COVE RD
WEST LINN, OREGON 97068

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATION OF 2.0 ACRES.

This right was perfected under Permit 18840. The date of priority is JULY 14, 1948. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.02 CUBIC FOOT PER SECOND (CFS) (IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, BEING: NE 1/4 SE 1/4, SECTION 22, TOWNSHIP 3 SOUTH, RANGE 1 EAST, W.M.; 10 FEET SOUTH AND 2310 FEET EAST FROM C 1/4 CORNER, SECTION 22), or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 22, T 3 S, R 1 E, W.M.; 3340 FEET NORTH AND 2325 FEET EAST FROM THE S 1/4 CORNER, SECTION 22.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.02 cubic foot per second.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

SW 1/4 NE 1/4 2.0 ACRES
SECTION 22
TOWNSHIP 3 SOUTH, RANGE 1 EAST, W.M.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;


the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered OCTOBER 14, 1986, approving Transfer Application 5823, and together with Certificate 56080, supersedes Certificate 45473, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
