CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARVEN AND ARDEEN ANDERSON

BAKER CITY, OR 97814

confirms the right to use the waters of POWDER RIVER, a tributary of SNAKE RIVER, for IRRIGATION of 250.6 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is 1863.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 6.26 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

Tract 2- ESTES WEST DITCH: NE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 8, T 9 S, R 40 E, W.M.; 110 FEET SOUTH & 600 FEET WEST FROM THE NE CORNER, SECTION 8

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW¼ SE¼ 40.0 ACRES
SW¼ SE¼ 38.8 ACRES
SE¼ SE¼ 38.0 ACRES

SECTION 30
TOWNSHIP 8 SOUTH, RANGE 40 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 73583, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered SEP 27 2006 approving Transfer Application T-8697.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
