

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THREE UNNAMED STREAMS, tributaries of SUMMER LAKE, for DOMESTIC USE FOR ONE HOUSEHOLD AND IRRIGATION OF 28.0 ACRES.

This right was perfected under Permit 41530. The date of priority is NOVEMBER 4, 1975. This right is limited to 0.705 CUBIC FOOT PER SECOND (CFS), BEING 0.07 CFS FOR IRRIGATION OF 2.8 ACRES FROM STREAM 1, 0.005 CFS FOR DOMESTIC AND 0.57 CFS FOR IRRIGATION OF 22.9 ACRES FROM STREAM 2, AND 0.06 CFS FOR IRRIGATION OF 2.3 ACRES FROM STREAM 3, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion (POD) are located as follows:

POD 1 (STREAM 1): NW 1/4 SW 1/4, SECTION 3, T 31 S, R 16 E, W.M.;
1900 FEET NORTH AND 100 FEET EAST FROM SW CORNER, SECTION 3

POD 2 (STREAM 2): NW 1/4 SW 1/4, SECTION 3, T 31 S, R 16 E, W.M.;
2350 FEET NORTH AND 230 FEET EAST FROM SW CORNER, SECTION 3

POD 3 (STREAM 2): NW 1/4 SW 1/4, SECTION 3, T 31 S, R 16 E, W.M.;
2250 FEET NORTH AND 550 FEET EAST FROM SW CORNER, SECTION 3

POD 4 (STREAM 3): NW 1/4 SW 1/4, SECTION 3, T 31 S, R 16 E, W.M.;
2200 FEET NORTH AND 1190 FEET EAST FROM SW CORNER, SECTION 3

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
