This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILHELM & ROSA MULLERLEILE RT 1, BOX 167A HILLSBORO, OREGON 97123

confirms the right to use the waters of AN UNNAMED STREAM AND A RESERVOIR, CONSTRUCTED UNDER PERMIT R-1211, tributaries of the ROCK CREEK, for IRRIGATION OF 14.8 ACRES.

This right was perfected under Permit 20532. The date of priority is APRIL 21, 1951. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.18 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 2, T 1 N, R 2 W, W.M.; 2030 FEET SOUTH AND 240 FEET WEST FROM THE N 1/4 CORNER, SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre irrigated from direct flow, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre feet each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1211.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NW 1/4 14.8 ACRES SECTION 2 TOWNSHIP 1 NORTH, RANGE 2 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered November 15, 1976, approving Transfer Application T-3484, and describes that portion of the water right confirmed by Certificate 26590, State Record of Water Right Certificates, NOT modified by the provisions of the order, and supersedes Certificate 26590, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment for that portion of the right not modified by the order.
