This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

confirms the right to use the waters of BADGER CREEK AND RESERVOIR, constructed under Permit R-773, tributaries of the WHITE RIVER, for IRRIGATION of 24.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 1.6 ACRES.

This right was perfected under Permit 27390. The date of priority is MARCH 22, 1961. This right is limited to a diversion of 0.28 cubic foot per second or its equivalent in case of rotation, measured at the point of diversion from the source.
