## CERTIFICATE OF WATER RIGHT

# THIS CERTIFICATE ISSUED TO

BIDWELL CRAM, AS TRUSTEE GATEWAY, OREGON 97220

confirms the right to use the waters of TROUT CREEK and HAY CREEK, tributaries to the DESCHUTES RIVER, for IRRIGATION OF 288.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 252.0 ACRES.

This right was perfected under Permit S-2716. The date of priority is NOVEMBER 12, 1915. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 6.7 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

## CRAM DITCH

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 2.5 acre-feet for each acre including water heretofore appropriated. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
