 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DOUBLE M RANCH, INC.
 31466 ANDREWS ROAD
 ECHO, OREGON 97826

confirms the right to use the waters of RALEY POND, a tributary of the UMATILLA RIVER, for SUPPLEMENTAL IRRIGATION of 30.50 ACRES.

This right was perfected under Permit 42204. The date of priority is MAY 5, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.193 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated, and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under this right, and to which such right is appurtenant, is as follows:

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.



The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate corrects a scrivener's error in the certificate recorded at page 81836, State Record of Water Right Certificates, describing the quarter-quarter to which 0.80 acre of water right is appurtenant. This certificate supersedes Certificate 81836.

This certificate confirms a change in PLACE OF USE authorized by an order of the Water Resources Director approving T-8865, entered JUNE 26, 2002, and recorded in Special Order Volume 56, Page 566.
